CONDITIONS OF ACCEPTANCE

1. Children must be dropped off no earlier than 8:30 am and picked-up no later than 3:30 pm unless the child is enrolled in the extended hours programme*.
Full-Day program hours: 8:30 am - 3:30 pm
(A separate application for extended hours is available from the office)
2. An up to date Immunization Record must be provided before or upon enrollment for each child.
3. Children must be fully toilette trained.
4. Children will be released only to the stated parent(s)/guardian(s) or other adult(s) as designated by the parents(s)/guardian(s).
5. The Academy reserves the right to withdraw a student from the programme if this is believed to be in the best interest of the child or the class.
6. A 2% per month interest charge will be applied to overdue fees.
7. Acceptance is conditional on meeting minimum enrollment requirements.
8. Tuition fee payments are not refundable. Parents/Guardians who choose to withdraw children before year end will be held responsible for the entire tuition.
